TTM Resources Inc. (TTQ.V: TSX) (the “Company”) announces the appointment of Mr. Marc Tran as Chief Financial Officer of the Company effective immediately. The Company has accepted Mr. Ron Jorgensen’s resignation and wishes to thank him for his past contributions.

Mr. Tran holds a Bachelor of Commerce in Finance and Bachelor of Science in Economics and is currently working on his CGA designation. He has been working in finance and accounting since 1999 in the oil and gas, service, and mining sectors. He is currently Secretary of Sonora Gold Corp. (SGG.V:TSX).

The Company also wishes to announce that it has engaged the services of Dr. William McConnell, of North Vancouver, British Columbia, to provide investor communication and corporate finance services for the Company to Canadian investors. In consideration for the services provided by Dr. McConnell, the Company will pay him a monthly fee of CDN\$2,000 commencing April 1, 2006 for an initial period of three months and is renewable thereafter on a month to month basis. The Company has also granted Dr. McConnell 100,000 incentive common stock options at \$0.30 per share for a period of two years.
