TTM Resources Engages Investor Relations Consultant in Europe

Exploration Update

TTM Resources Inc. ("TTM") announces that it has entered into a Consulting Agreement with Small Cap Invest Ltd. ("SCI"). SCI is a European public relations firm for small and medium sized public companies with Mr. Alexander Friedrich as President & C.E.O. SCI will provide investor relations advisory services to TTM, including, but not limited to, translating TTM corporate information, establishing a profile of TTM with French and German-speaking financial and institutional investors.

In consideration for their services, the Company will pay to SCI a fee of \$5,000 Euros per month plus expenses. SCI will also receive 200,000 options exercisable at \$0.30 Cdn for a 2 year period. The agreement becomes effective July 1, 2006 for an initial 6-month term and thereafter subject to a 30-day termination clause by either party.

The above is subject to approval by the regulatory authorities.

TTM also announces diamond drilling has commenced on the ROAD ZONE within the 25,000 hectare MOLY GOLD project. Hole # 2006-1 was completed to a depth of 290 meters at a -45 degree angle and was shut down due to hole conditions. The core has been logged and split and the complete hole will be submitted for assay. Hole 2006-2 at -90 from the same setup is currently at 76 meters depth and will continue to depth as long as the company's on site geologist and director C.K. Ikona P. Eng. (qualified person under 43-101) deems it to be of interest.
